Subject: Six-Year Comprehensive Transportation Improvement Program

Overview of Program

Section 35.77.010 of the Revised Code of Washington (RCW) provides that the legislative body of each city and town prepare and adopt a comprehensive transportation program for the ensuing six calendar years and filed with the Secretary of Transportation of the State of Washington. Section 35.77.010 of the RCW further provides that each city will include in their comprehensive transportation program how they intend to expend the revenues for non-motorized transportation purposes.

Cities and towns are required to update and adopt their Six-Year Comprehensive Transportation Improvement Program (Program) annually. The program is necessary to allow the City to compete for and obtain state and federal grant funding. The Program serves as a tool to implement the Transportation and Mobility Plan.
