# **City Staff Updates – City Staff**

- City of Tacoma Website: The City of Tacoma's new website is now live. An email was sent to the EIC Advisory committee.
- EIC Annual Report Update: An update will be provided at the next meeting as we are awaiting some data from the B2Gnow Team.
- Outreach Plan Updates: Applications have opened for the Business Tax Class. Higher than Me Consulting was
  hired to provide a 3-hour class that will cover business tax preparation and compliance, financial management
  and best practices, business and personal expense management, modern financial systems and automation,
  common tax filing mistakes, and how to avoid them, and the importance of separating personal and business
  finances. Following this class, participants will be able to meet one-on-one with the CPA.

The remaining EIC Outreach plan for the year includes Access to Capital, OMWBE Series, and a business resources class in partnership with organizations like Business Impact NW, Department of Commerce and Tacoma Pierce County Chamber of Commerce. EIC Advisory Members are asked to help promote upcoming outreach program.

Members were told to contact EIC Staff to renew their term. Trena Payton responded she would submit an email shortly, Clint and Justin responded they would renew their terms.

**Committee Discussion – City Staff and Committee Members** 

- a) Roberts Rule of Order Meeting Etiquette: Reminder to EIC Advisory Members to abide by Robert's rule of order for Meeting Etiquette.
- b) Annual Work Plan Review and Document Progress
  - Internal Processes Subcommittee Updates EIC Advisory members were asked to provide the best time and day to schedule future subcommittee meetings It was decided that Mondays before 3PM would be the best time for all.
    - On this topic, Clint added that he would advocate for prime contractors to be able to submit their EIC Paperwork an hour after bid opening to ensure there are no mistakes. He shared his frustration as a prime contractor when he loses a 3.5-million-dollar job because of an EIC Mistake. Angela also added that she would be interested to see the EIC Program having a trucking form like WSDOT to track material vs trucking on EIC Utilization. Clint responded by saying that it's harder to reach the goal when there is a distinction between trucking vs material supply. He added that currently contractors get credited 100% utilization when trucking firms supply materials and provide trucking services. He added that if EIC adopted a trucking form and started separating trucking vs material, it would push contractors away from trucking firms like Angela's. Clint concluded by saying that if the City makes processes more stringent for contractors, we will find ourselves in a position where nobody will be able to meet the goals, and all bids will be rejected creating bigger issues.
  - Workforce Subcommittee Updates: No updates at this time EIC Staff was asked to share the
    Workplan spreadsheet with the EIC Advisory Committee for review. Discussions were started
    regarding a future potential loan program to assist businesses working on City of Tacoma Projects.
    This discussion was a nice segue into the upcoming access to capital workshop. A draft of the loan
    program will be sent to the EIC Advisory Members.
  - Data Subcommittee No updates to provide on this one as EIC Advisory Members are currently
    waiting for more data from EIC Staff. Topic will remain for discussions during meeting
  - **Certifications subcommittee** Clint initiated the conversation by suggesting adding Veterans Certification to the City's EIC Requirements.
    - Angela raised questions about increasing the overall goal to accommodate veteran businesses. Rahsaan added that the process needs to be less cumbersome for all parties involved. Adding the Veteran Certification would benefit minorities & women as well as many are veterans as well. It was decided to explore the option of adding Veteran certification to the EIC Requirements. Discussions will take place during the Internal Processes Subcommittee meeting.

Topic will remain for discussions during meeting. Topic will need to be explored further

• Trainings & Workshops – Topic will remain for discussions during meeting. Linda would like to schedule subcommittee meeting to get some input from the EIC Advisory members. Linda shared information on upcoming workshops including the Business Tax preparation delivered by Higher than me Consulting. This is a 3-hour class that will cover business tax preparation and compliance, financial management and best practices, business and personal expense management, modern financial systems and automation, common tax filing mistakes, and how to avoid them, and the importance of separating personal and business finances. Attendees will benefit from a shared 45-hour pool, where they can meet with the CPA individually and discuss their business questions. Linda also shared information on the upcoming Access to capital class in partnership with other agencies like Business Impact NW, Department of Commerce and Tacoma-Pierce Chamber of Commerce.

On the topic of Access to Capital, Michael shared some information on the CRP Grant: A lot of firms were able to receive the grant which was reimbursement based. A few organizations had the capital on hand to be able to do the work and get reimbursed for it. Michael added that there is a need for partnership and increase of relationships. A lot of organizations were awarded the opportunity to disburse the CRP fundings however, the policy changes and delays were difficult to manage. Additional information was shared about an upcoming event scheduled for September 25th sponsored by Tacoma Public Schools, Parks Tacoma and City of Tacoma which will bring together prime contractors, subcontractors and small business technical assistance.
